Specific Duties - Clinical Psychologist. The healthcare worker (HCW) shall provide services within the scope of their competencies including:

- 1. Administer programs of treatment to mentally and emotionally disturbed individuals; help medical and surgical patients deal with illnesses or injuries.
- 2. Assist in treating rehabilitation patients.
- 3. Treat individuals in times of personal crisis such as a divorce or death of a loved one.
- 4. Interview patients and study medical and social case histories.
- 5. Diagnose and evaluate mental and emotional disorders of individuals and administer programs of treatment.
